

Frequently Asked Questions About Leasing Your Recreation Equipment

Who can lease?

Playworld Systems can lease equipment to any school, company, organization or association. However, we can not lease equipment to an individual for personal use.

What is the process for leasing equipment?

Simply complete the attached Equipment Lease Application. The Equipment Lease Application along with Equipment Proposal are faxed or mailed to Playworld Systems' Lease Administrator. Credit decisions are usually made within 1 business day from the time of receipt. Upon approval, you will be contacted by a leasing representative to discuss lease finance terms and to finalize the lease agreement. Once the agreement is signed and returned, we can begin the order process.

Is a down payment required?

A security deposit, in addition to the first months payment, is required in advance. This differs from a down payment in that the amount is typically much less. The deposit can be applied to the purchase price of the equipment at lease-end, or returned if there are no other payments due.

How are lease payments determined?

The monthly payment is based upon the term of the lease and cost of the equipment, freight, and/or installation (if the lessee so chooses). The initial term of a lease runs from 12 to 60 months.

What factors are used to determine credit worthiness?

Type of business, length of time in business, financial condition, references from financial institutions, and D&B or other credit bureau ratings are reviewed during the credit process.

What happens at the end of the lease?

At the end of the lease term, the recreation equipment is simply purchased for \$1.00.

(A nominal charge for processing the title transfer may also apply.)

Who installs or maintains the equipment?

The lessee is responsible for having the recreation equipment installed. You may choose to include your installation cost in the lease contract. Your Playworld Systems Consultant can install your play equipment to Playworld Systems' specifications. The lessee is responsible for maintenance and receives the benefits of all "buyer" warranties.

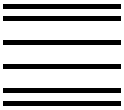
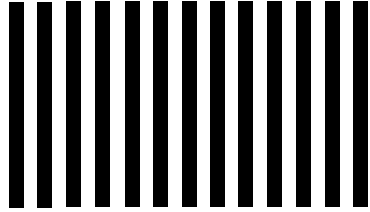

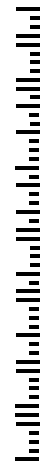
